

COVID-19 Preparedness & Response: Mobility Update Week 8 (11-17 May 2020)

Background and Methodology

DTM relies on its network of key informants and on secondary sources to provide a weekly assessment of mobility and COVID-19 preparedness at priority locations in South Sudan. The updates are released in the beginning of each week based on information collected Monday–Sunday of the previous week. Table 2 on page 2 represents only points recommended by the Points of Entry Technical Working Group (PoE TWG). A more exhaustive list of entry and transit points can be found here.

Overview

As of 17 May 2020, the High-Level Task Force (HLTF) on COVID-19 has confirmed 347 cases of the virus in South Sudan. The first death was recorded on 14 May, rising to six by the end of the reporting period. On 17 May 2020, South Sudan's first vice president and chairman of the HLTF, Dr. Riak Machar Teny Dhurgon, and the Defense minister, Angelina Jany Teny were announced to have <u>tested positive</u> for COVID-19 as well as seven other HLTF members. As of 13 May 2020, a presidential statement indicated that another lockdown is not excluded amidst the rise of cases across the country. This news came after some COVID-19 related restrictions such as internal and international flights were eased as announced on 7 May 2020.

As of 11 May 2020, two COVID-19 cases were confirmed at the UNMISS <u>Juba Protection of Civilian (PoC) 3</u> <u>site</u>. At the time of writing, one of the cases was transferred to the IDU (Infectious Disease Unit) for further medical attention and quarantine. The lockdown as Malakal PoC site, which started on 27 April 2020 was lifted on 12 May 2020.


The price of common goods is reported to have increased in states such as Northern Bahr el Ghazal due to COVID-19 related policies hindering imports. Truck drivers in Nimule continue to face challenges crossing the border into South Sudan as movement restrictions impose a heavy bureaucratic burden on local authorities.

DTM tracked COVID-19 related movement trends at 68 locations consisting of 14 displacement sites and 54 transportation hubs of which 31 are located along South Sudan's borders. While no disruption to the movement of persons was recorded at 23 tracked transport hubs (43%), local movement was tolerated at four points (7%) or maintained through alternative crossing points at nine points (17%). Some risk communication was reported to be conducted at all tracked sites but not for nearly three-quarters of transportation hubs (30 points or 65%). Temperature screening was present at two displacement sites and six transportation hubs (14% and 11% respectively).

Key insights on countries bordering South Sudan

- SUDAN: Movement restrictions through Abyei have been maintained. However, DTM has received reports of border crossings through alternative nearby points. Movement in the west through Raja and the Aweils continues while enforced restrictions in Rubkona, Renk and Maban seem to have halted travel between Sudan and South Sudan.
- ETHIOPIA: Movements of cargo and persons to and from Ethiopia have continued only through Akobo as travel through other points of entry has halted according to available data.
- UGANDA: DTM focal points in Elegu confirmed reports of arrests of travelers attempting to cross into Uganda from South Sudan using alternative roads near Elegu (UGA) / Nimule (SSD). While authorities have focused much of the available resources on major crossing points such as Nimule, the border remains porous and cross-border movements by local communities are commonly tolerated.
- DEMOCRATIC REPUBLIC OF CONGO: Gangura and Bazi points of entry have both been closed for movement of cargo and persons while movement via panya routes (smaller local routes crossing the border) is still being observed.
- CENTRAL AFRICAN REPUBLIC: Source Yubu point of entry is closed for movement of persons and cargo. However, movement through alternative routes around the border point is ongoing.
- KENYA: The border point between Kenya and South Sudan (Nadapal) remains open for the movement of cargo only. Travelers still find their way into or out of South Sudan through alternative routes.

COVID-19 Timeline (part 1/2: 19 March - 18 April 2020)

High Level Task Force

The Government of South Sudan establishes the High Level Task Force on Vice President Dr. Riak Machar.

Closure of edu. facilities

South Sudan Vice President for Service Cluster Hussein Abdelbagi Akol has decided COVID-19 led by The First to close all the schools, teachers training institutes and the universities across the country.

Uganda suspends refugee policy

Uganda's open-door policy for refugees and asylum seekers is suspended for 30 days. Refugees who are already in the country will continue to receive support.


The South Sudan Government confirmed its first ase of COVID-19

Long distance learning

Education ministry to launch distance learning for students. Lessons for core subjects for primary and secondary school students will be delivered over radio stations and national television.

Release of 143 prisoners

Authorities in South Sudan has released 143 prisoners in an effort to combat the spread of the new coronavirus disease in crowded jails.



Preparedness & Response Plan

Ministry COVID-19 releases Country Preparedness and Response Plan (April - September 2020)

South Sudan closes borders

South Sudan closes all airports and seals land borders for passengers. Curfew across country from 8.00PM to 6.00AM. Public institutions working half-time. First suspected case of COVID-19 tested negative.

Quarantine Escape

Over 500 South Sudan nationals described as returnees <u>escape</u> quarantine in Renk, set up at a secondary school after arriving from Sudan.

Closing of Wau Collective Centres

The Diocesan Major Response Team on COVID-19 decides to close several Wau collective centres. As of 12 April 2020, Nazareth, Cathedral, St. Joseph

and Lokoloko (3,743 ind. in March 2020 according to DTM population count) are empty apart from a few stranded households.

Suspension of inter-state travel

The Government has suspended passenger flights as well as public and private iner-state transport for up to two weeks effective from midnight Wednesday 15 April 2020 (Communication from the presidency 25, HLTF 13 April 2020).

Increased testing in Juba

The HLTF directs the Ministry of Health to divide Juba into five zones and to collect over 100 samples per week per zone to enable a minimum

testing capacity of 500 samples a week (Communication from the presidency 28, HLTF 16 April 2020).

Extensions of restrictions

The Government's High-level Security forces put the Taskforce on combating the UNMISS base and Malakal COVID-19 pandemic extended all PoC site under lockdown restrictions introduced in March due to COVID-19 in 2020 until further notice as a Malakal County. precautionary measure.

Malakal PoC site lockdown

First recoveries

The ministry of helath announces that two coronavirus patients in South Sudan have recovered from the disease.

Relaxation of measures

The Presidency announces a relaxation of COVID-19 measures as of 8 May 2020 including a curefew from 10pm-6am and the loosening of other congregation restrictions without their complete

36 new cases: 156

36 new cases among 282 tests of the last 48 hours: 28 travellers to other states and remaining contacts of previously confirmed cases.

18 new cases: 174


South Sudan Civil Aviation Authority has officially announced the reopening all airports to domestic and international flights.

Re-opening of airspace Possibility further lockdown

President announces that another lockdown is not excluded amidst the rise of COVID-19 cases across the country

Riek Machar tests positive

Riek Machar, Angelina Teny (Minister for Defense) and 7 other HLTF members test positive to COVID-19. 57 new cases on 17 May 2020 bringing the total to 347.



IDPs leave Wau PoC AA

265 households (992 IDPs) registered and picked up a return package, although not all have left, IOM DTM confirms an increase in intended permanent exits from Wau PoC AA peaking between 7 and 12 April.

Internal movement restrictions

Suspension of all public transportation system between Juba and all other towns and villages in Central Equatoria, and between Torit and all other towns and villages in Eastern Equatoria.

UGA border

Elegu/Nimule crossing point due to long who did not adhere to waiting times upon entry stay-at-home orders. to South Sudan as SSD officials requesting money for testing on entry and when leaving the country.

Drivers strike at Forced Quarantine

Truck Drivers strike at the forceful quarantine border of COVID-10 patients

The Government begins

First Bentiu PoC site case confirmed

The first COVID-19 case confirmed at Bentiu PoC site. Partners begin contact tracing and continue in the construction of a Bentiu

Town isolation centre.

Trucks stranded in Elegu

"Hundreds of" trucks are reported to be stranded in Elegu (UGA), bordering Nimule. The drivers are said to be awaiting clearance from South Sudanese authorities.

First Juba PoC site cases confirmed

The first COVID-19 cases are confirmed luba PoC 3 site.

Malakal PoC site lockdown end

Government security forces have lifted the lockdown (1) at Malakal PoC site.

First death

The HLTF confirmes 28 new cases bringing the total number of cases to 231 with three recoveries 444 and death.
