

COVID-19 Preparedness & Response: Mobility Update Week 9 (18-24 May 2020)

Background and Methodology

DTM relies on its network of key informants and on secondary sources to provide a weekly assessment of mobility and COVID-19 preparedness at priority locations in South Sudan (reporting period Monday to Sunday). Table 2 on page 2 represents only points recommended by the Points of Entry Technical Working Group (PoE TWG). A more exhaustive list of entry points can be found here.

Overview

As of 24 May 2020 the number of confirmed COVID-19 cases in South Sudan stands at <u>655</u> of which 95 per cent were recorded in Juba. As per a presidential communication on 18 May 2020, a new National Taskforce Committee on Coronavirus Disease is to continue activities previously carried out by the High-Level Taskforce Committee on COVID-19.

According to the Famine Early Warning Systems Network (FEWS NET) the relaxation of restrictive congregation and travel measures announced on 8 May 2020 have caused market and <u>trade activities to rebound</u> but that concerns for the "direct impacts of COVID-19 on the food security of at-risk households" remain.

Efforts to prevent further spread of the virus remain by implementing policies such as forced quarantine and movement restrictions remained curtailed during this reporting period by limited resources as highlighted by the <u>escape of 24 persons</u> who were to remain in quarantine in Kapoeta South County due to insufficient food supplies.


DTM gathered data on 19 displacement sites, 33 land borders, 14 in-country transit hubs and 7 airports. Among monitored non-displacement site locations (54), DTM found that the movement of persons had halted at 17 (31%) but that travel continued without interruption at 23 (43%) or through alternative nearby points (9 or 17%). Temperature screening was conducted at six locations (11%), handwashing stations were available at 21 (39%) and risk communication was carried out at nearly half of locations (26 or 48%).

Temperature screening was recorded as being available at 3 out of 19 tracked displacement sites (16%) but nearly all made handwashing stations available (17 sites or 89%). Some form of risk communication was carried out at all tracked displacement sites.

Key insights on countries bordering South Sudan

- SUDAN: Movement of persons has continued through most points of entries along the Sudan border.
 A joint team from WHO, Save the Children & MOH visited Abyei and trained eight volunteers who will
 be conducting temperature screening. Following a PoE TWG assessement in Renk (14-20 May 2020),
 DTM established a Flow Monitoring Point in Wunthou to better capture the movement of persons and
 cargo due to the point's geographical location as a convergence point for cross-border routes between
 Sudan and South Sudan.
- ETHIOPIA: Akobo remains the only active point of entry for movement of persons and cargo while seven others are open only for movement of cargo.
- UGANDA: While the movement of cargo is permitted, delayed bureaucratic processes linked to COVID-19 restrictions have caused long queues of trucks at the Elegu / Nimule border. The issue of stranded truck drivers is a regional one fuelling fears the crowded border areas might become the next hot spots of the disease.
- DEMOCRATIC REPUBLIC OF CONGO: Gangura and Bazi remain open for movement of cargo with continued movement of persons across alternative nearby routes.
- CENTRAL AFRICAN REPUBLIC: Movements of persons via alternative routes through Source Yubu and Ezo Centre points of entries have continued via alternative routes.
- KENYA: The Nadapal border point remains open for the movement of cargo and closed for the movement of persons.

High Level Task Force

The Government of South Sudan establishes the High Level Task Force on COVID-19 led by The First Vice President Dr. Riak Machar.

Closure of edu. facilities

South Sudan Vice President for Service Cluster Hussein Abdelbagi Akol has decided to close all the schools, teachers training institutes and the universities across the country.

Uganda suspends refugee policy

Uganda's open-door policy for refugees and asylum seekers is suspended for 30 days. Refugees who are already in the country will continue to receive support.



Closing of Wau Collective Centres

The Diocesan Major Response Team on COVID-19 decides to close several Wau collective centres. As of 12 April 2020, Nazareth, Cathedral, St. Joseph and Lokoloko (3,743 ind. in March 2020 according to DTM population count) are empty






