EMERGENCY TRACKING TOOL (ETT)

The DTM Emergency Tracking Tool (ETT) is deployed to track and to collect information on large and sudden population movements, provide frequent updates on the scale of displacement and quantify the affected population when needed. As a subcomponent of the Mobility Tracking methodology in Nigeria, ETT utilises direct observation and a broad network of key informants to capture best estimates of the affected population per location, enabling targeted humanitarian response planning.




Between 24 and 30 May 2021, a total of 1,858 movements were recorded in the states of Adamawa and Borno. The recorded movements consisted of 1,228 arrivals and 630 departures. Arrivals were recorded at locations in Askira/Uba, Bama, Gwoza, Kala/Balge and Ngala Local Government Areas (LGAs) of the most conflict-affected state of Borno and in Demsa, Fufore, Girei, Gombi, Hong, Lamurde, Madagali, Maiha, Michika, Mubi North, Mubi South, Numan, Song and Yola South LGAs of Adamawa.

Departures were recorded in Askira/Uba, Bama, Gwoza and Konduga LGA of Borno, and Demsa, Fufore, Hong, Lamurde, Madagali, Maiha, Michika, Mubi North, Mubi South, Numan, Song and Yola South LGAs of Adamawa.

ETT assessments identified the following movement triggers: voluntary relocation (796 individuals or 43%), poor living conditions (589 individuals or 32%), improved security (322 individuals or 17%), fear of attack (120 individuals or 6%) and conflict/attack (31 individuals or 2%).

SUMMARY OF MAJOR MOVEMENTS

Askira/Uba: 205 arrivals and 149 departures were recorded in Askira/Uba LGA of Borno State. The arrivals included 110 individuals from within Askira/Uba LGA in Borno State, 66 individuals from Hong LGA in Adamawa State, 19 individuals from Potiskum LGA in Yobe State and 10 individuals from Damaturu LGA in Yobe State. The departures included 77 individuals to Madagali LGA in Adamawa State and 72 individuals to Chibok LGA in Borno State. Seventy per cent of the movements recorded were due to poor living conditions, 27 per cent of the movements recorded were a result of the improved security situation in areas of origin, and 3 per cent of the movements recorded were voluntary relocation.

Michika: 97 arrivals and 59 departures were recorded in Michika LGA of Adamawa State. The arrivals included 49 individuals from Song LGA in Adamawa State, 22 individuals from Madagali LGA in Adamawa State, 21 individuals from Yola South LGA in Adamawa State and 5 individuals from Hong LGA in Adamawa State. The departures included 32 individuals to Fufore LGA in Adamawa State and 27 individuals to Gwoza LGA in Borno State. Thirty-five per cent of the movements recorded were due to poor living conditions, 34 per cent of the movements recorded were a result of the improved security situation in areas of origin and 31 per cent of the movements recorded were voluntary relocation.

Madagali: 77 arrivals and 71 departures were recorded in Madagali LGA of Adamawa State. All arrivals were from Askira/Uba LGA in Borno State. The departures included 22 individuals to Hong LGA in Adamawa State, 21 individuals to Mubi South LGA in Adamawa State, 16 individuals from Gwoza LGA in Borno State and 12 individuals to Madagali LGA in Adamawa State. Sixty per cent of the movements recorded were due to conflicts/attacks, 14 per cent of the movements recorded were due to poor living conditions and 11 per cent of the movements recorded were voluntary relocation.

Hong: 78 arrivals and 51 departures were recorded in Hong LGA of Adamawa State. The arrivals included 43 individuals from Song LGA in Adamawa State and 35 individuals from Hong LGA in Adamawa State. The departures included 29 individuals to Askira/Uba LGA in Borno State and 22 individuals to Hong LGA in Adamawa State. Seventy-eight per cent of the movements recorded were voluntary relocation and 22 per cent of the movements recorded were due to improved security situation in areas of origin.

IOM's Emergency Tracking Tool (ETT) is deployed in Nigeria's northeastern states. Only Local Government Areas (LGAs) in which the IDP population changed since the latest DTM round of assessments are represented in this report. The data has been collected by DTM staff deployed at the locations listed and cross-checked with the partners present on the ground.

NEW ARRIVAL MALNUTRITION SCREENING SUMMARY (CHILDREN 6-59 MONTHS)

An exhaustive nutrition screening using mid-upper arm circumference (MUAC) and oedema for acute malnutrition was conducted by sector partners for 37 children of 6-59 months. Of the 37 children screened, the MUAC reading indicated that 1 child was recorded in the red category, 1 child in the yellow category and 35 children in the green category. No case of oedema was reported in the 3 LGAs assessed.

The results also included 18 children who arrived from neighbouring countries (all in Bama). All the children measured were recorded in the green category, with none in red and yellow categories. All children found with acute malnutrition have been admitted for treatment. Please note, the data presented are not surveillance results and should be interpreted with caution.
