369% increase in displacement from the previous week (36 HHs)

IOM Yemen DTM's Rapid Displacement Tracking (RDT) tool collects data on estimated numbers of households forced to flee on a daily basis from their locations of habitual residence or displacement, allowing for regular reporting of new displacements¹ in terms of estimated numbers, causes of displacement, geography and needs. It also tracks returnees who returned to their location of habitual residence.

Between 17 July and 23 July 2022, IOM Yemen DTM tracked 169 households (1,014 individuals)² who experienced displacement at least once. This represents a stark increase in comparison to the previous week (+369%). The increase was mainly driven by conflict in Marib and floods in Al Jawf. Conflict in the form of combat or shelling displaced 68 households from Harib (64HHs), and four households from two further districts. Displacement was primarily within the same district to locations such as Al-Adi, Al-Had Al Rawdhah, Al-Seih, Hareib and Shadeiqah.

Flooding caused displacement within Al Jawf's Khab wa Ash Shaf to Al Mahashemah (51 HHs). Most instances of these flood induced population movements were not new displacements but movements by already displaced households.

Overall, safety and security concerns as a result of the conflict were the main reason for displacement, accounting for 60 per cent (102 HHs) of the total, while 30 per cent (51 HHs) were displaced due to the natural disaster, followed by economic reasons related to conflict, accounting for 10 per cent (16 HHs).

Between 1 January to 23 July 2022, IOM Yemen DTM tracked 7,348 households (HH)³ (44,088 Individuals) who experienced displacement at least once.


Overall, since the beginning of the year, the number of tracked new instances of displacement has been declining in an irregular pattern.


