

Flooding in Al Galabat Al Gharbyah-Kassab, Gedaref



UPDATE I: 6 September 2022

EMERGENCY EVENT TRACKING

Data collection: 1 September 2022

The DTM Emergency Event Tracking (EET) is deployed to track sudden displacement and population movements, provide more frequent updates on the scale of displacement, and quantify the affected population when needed. As a subcomponent of the new Mobility Tracking methodology in Sudan (Round Four), and activated on a need basis, EET utilises a broad network of key informants to capture best estimates of the affected population presence per location – a useful tool for humanitarian response planning and design.

Event Overview





DTM teams activated EET to monitor the displacement of individuals affected by heavy rains and flooding in locations across Al Galabat Al Gharbyah-Kassab locality, in Gedaref state on 28 August 2022. The first EET update estimates that a total number of 19,560 individuals (3,366 households) are currently displaced across the villages of Afrosh Tobac Ganoub (15%), Bandeghio (14%), Afrosh Tobac Shamal (12%), Karsh Alfeel (11%), Alrigab (10%), Dar Alsalam (7%), Alazaza Albaida (5%), um Hojara (5%), Ardiba Altejani (4%), Ardiba Hassan Korsi (4%), Aldeleeb (4%), and other locations (9%) in Al Galabat Al Gharbyah-Kassab across Gedaref state. The IDP caseload (100%) was originally displaced from the above-mentioned villages and currently seeking shelters in gathering sites located at the higher grounds.

DTM field teams have confirmed that no individuals were killed or injured. There are at least 3,239 reported cases of lost goods, livestock, and/or cattle. All displaced individuals are Sudanese nationals. At least 525 cases of additional vulnerabilities in need of assistance and support were identified by key informants through DTM's Protection Indicator. Additionally, DTM Sudan estimates that there are approximately 2,934 persons with disabilities among the IDP caseload.* Based on a ranking scale, the three priority needs across the caseload are Emergency Shelter, Food and Health (medical needs).







* DTM Sudan adopts the WHO global estimate that approximately 15% of the total population are persons with disabilities
