





From the period 30 September – 6 October 2019, a total of 1,344 movements were recorded, which were composed of 1,014 arrivals and 330 departures. Arrivals were recorded at locations in Askira/Uba, Bama, Damboa, Dikwa, Gwoza, Kaga, Kala/Balge, Konduga, Maiduguri, Mobbar, Monguno and Ngala Local Government Areas (LGAs) of Borno State. Arrivals were also recorded in Gombi, Hong, Maiha, Michika, Mubi North, Numan, Song and Yola South LGAs of Adamawa State. Departures were recorded in Maiduguri Metropolitan Council, Askira/Uba, Bama and Kala/Balge LGAs of Borno State. Departures were also recorded in Girei, Gombi, Hong, Madagali, Maiha, Michika, Numan, Song and Yola South LGAs of Adamawa State.

ETT assessments identified the following movement triggers: voluntary relocation (32%), poor living conditions (29%), conflict/attack (17%), military operations (12%), improved security (7%), fear of attack (2%) and involuntary relocation (1%).

### **SUMMARY OF MAJOR MOVEMENTS**

Askira/Uba: 229 arrivals and 4 departures were recorded in Askira/Uba LGA of Borno State. The arrivals include 9 from Akko LGA of Gombe State. Other arrivals include 18 from K/Wuro Ngayandi ward and 202 from Chull/Rumirgo ward and were tracked at Mussa and Uba wards. The 4 departures were from Hausara/Tampul Ward. 71% of the of the new arrivals reported to have relocated due to the ongoing conflict, 12% due to improved security, 9% due to fear of attack while 8% were reportedly due to poor living conditions. The departures were all voluntary.

Bama: 172 arrivals and 21 departures were recorded in Bama LGA of Borno State. The arrivals include 35 from Darajamal ward and 18 from Buduwa/Bula Chirabe ward. Other arrivals include 78 from Mora in Cameroon, 22 from Dalori/Wanori ward of Konduga LGA, 13 from Mafa ward of Mafa LGA and 6 from Pulka/Boko ward of Gwoza LGA. The 21 departures were from Buduwa/Bula Chirabe ward. 53% of the new arrivals reported to have relocated due to poor living conditions, 36% relocated voluntarily while 10% were reportedly involuntary. The departures were all voluntary.

Maiduguri: 125 arrivals and 8 departures were recorded in Maiduguri Metropolitan Council of Borno State. The arrivals include 7 from Benishikh ward of Kaga LGA. Other arrivals include 101 from Jewu/Lamboa, 9 from Auno Chabbol and 8 from Sojiri/Nguro-Nguro wards of Konduga LGA. The 8 departures were from Mafoni ward. 88% of the new arrivals reported to have relocated due to military operations, 6% due to fear of attack while 10% were reportedly due to poor living conditions. The departures were due to poor living conditions.

Numan: 33 arrivals and 57 departures were recorded in Numan LGA of Borno State. The arrivals include 17 from Sabon Pegi ward and 16 from Demsa LGA of Adamawa State. The departures include 44 from Gamadio ward and 13 from Imburu. 88% of the new arrivals reported to have relocated due to military operations, 52% due to poor living conditions while 48% were reportedly voluntarily. The departures were all voluntary.

### **NEW ARRIVAL MALNUTRITION SCREENING SUMMARY (CHILDREN 6-59 MONTHS)**

An exhaustive nutrition screening using monitoring of symptoms of acute malnutrition mid upper arm circumference (MUAC) and Oedema was conducted by Nutrition Sector partners for 116 children of 6-59 months. Of the 116 children screened, the MUAC reading recorded 5 children (from accessible areas) in the Red category, 14 in the Yellow category and 97 measured in the Green category. No cases of Oedema were reported in the 6 LGAs reports were received from.

The results also include 19 children from neighbouring Cameroon, Chad and Republic of Niger (11 childrend moved to Bama, 7 to Mobbar and 1 moved to Ngala); out of the 19 children measured, 1 was in the red category, 15 were in the green category and 3 were in the yellow category. All children found with acute malnutrition have been admitted for treatment.
