

Displacement Tracking Matrix | DTM Sudan

Barbar, River Nile UPDATE 1: 30 AUGUST 2022

EMERGENCY EVENT TRACKING Data collection: 17 August 2022

As a subcomponent of the Mobility Tracking methodology (<u>Round</u> <u>Four</u>), the Emergency Event Tracking (EET) tool is deployed to track sudden displacement, provide more frequent updates on the scale of displacement, and quantify the affected population when needed.






DTM teams activated EET to monitor the displacement of individuals affected by heavy rains and floods around El Makailab and Kadabas villages in Barbar locality, River Nile state on 17 August 2022. The first EET update estimates that a total number of 10,245 (2,049 households) were originally displaced from the villages of Almakailab (62%), Alsowktab (9%), Algobush (6%), Kadabas (5%), Altelwab (5%), Almaseed (4%), Alsadabia (4%), Alfahalb (4%) and Algemerab (2%) in Barbar locality in river Nile state. The IDP caseload is currently seeking shelters in gathering sites located at the higher grounds across above-stated villages.

DTM field teams have confirmed that 16 individuals were killed, no individuals were injured and there are 1,241 reported cases of lost goods, livestock, and/or cattle. All displaced individuals are Sudanese nationals. At least 508 cases of additional vulnerabilities in need of assistance and support were identified by key informants through DTM's Protection indicator. Additionally, DTM Sudan estimates that there are approximately 1,537 persons with disabilities among the IDP caseload.* Based on a ranking scale, the three priority needs across the caseload are Emergency Shelter, Non-Food Items, and Food.





* DTM Sudan adopts the WHO global estimate that approximately 15% of the total population are persons with disabilities (PwDs).
