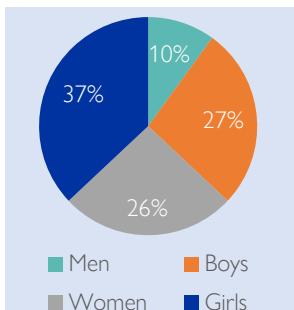

The objective of the Emergency Tracking Tool (ETT) is to collect information on large and sudden population movements as well as security and climactic emergencies. Information is collected through phone interviews with key informants and direct observation. This report presents the results of an **assessment conducted in the field from 23 to 25 September 2022** in the sous-préfecture of Karal, department of Dagana, province of Hadjer-Lamis.

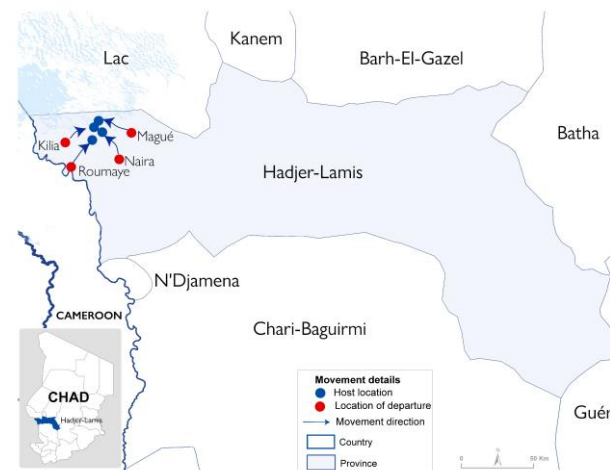

OBSERVATIONS AND ANALYSIS



The 473 households (3,485 individuals) were displaced in the same sous-préfecture of Karal and are being hosted by host families. Among these, **73 households (357 individuals)** are in the villages of **Hilé Djogala**, **137 households (1,288 individuals)** in **Baltrame**, **150 households (1,010 individuals)** in **Karga** and **113 households (830 individuals)** in **Malmouri 2**. However, most of the displaced individuals are sleeping in open air, as there is not sufficient shelter.



The displaced persons lost most of their main sources of livelihood (agriculture, livestock and small businesses). Additionally, lack of food was cited as a major problem and thus far, **no assistance has been apart from some basics, namely food, provided by the host community**. However, this remains insufficient to cover their food needs.



Cases of malaria and typhoid fever have been reported. Due to lack of medical staff, health facilities, open defecation, shelter and food, the health situation is likely to worsen.



Vulnerable groups reported include **48 pregnant women, 09 child heads of household and 24 separated children, among them 13 are girls**.



All households reported urgent needs in **non-food items, especially blankets, mats, soap, mosquito nets, cooking utensils and water storage containers**.

SUMMARY OF THE EVENT

Due to an armed attack which occurred on **16 September 2022** by armed groups in the locality of Naira (sous-préfecture of Karal, department of Dagana), contributing to the decline of the security situation in this province, **473 households (3,485 individuals)** of the host population, were forced to leave the villages of Kilia, Magué, Naira and Roumaye (located in the same sous-préfecture). These people took refuge in the villages of Hilé Djogala, Baltrame, Karga and Malmouri 2 (same sous-préfecture) on **16 and 17 September 2022**. These displaced persons, made up mostly of women and children, traveled to these localities on foot, by riding animals and by canoe. In addition to these displacements, this incident caused the death of 07 individuals and the loss of livelihoods and non-food items.
