

IOM ZIMBABWE ZIMBABWE FLOW MONITORING

JUNE 2020

HIGHLIGHTS

- ⇒ A total of 59,551 regular movements (26,800 at Beitbridge Border Post, 11,400 at Forbes Border Post and 21,351 at Chirundu Border Post) were observed during the month in review.
- ⇒ A total of **10,080** returnees were received across the country in a period of **three** months.

This report gives an overview of data collected on regular movements at three Points of Entry (PoEs), Beitbridge, Forbes and Chirundu. The data collected represents only a part of the total populations passing through the various PoEs in Zimbabwe.




Fig 1- Location of observed Points of Entry

DEFINITION OF KEY TERMS

REGULAR MIGRATION: Movement of persons that occurs in compliance with the laws of the country of origin, transit and destination. (IOM Glossary - 2019)

IRREGULAR MIGRATION: Movement of persons that takes place outside the laws, regulations or international agreements governing the entry into or exit from the State of origin, transit or destination. (IOM Glossary - 2019)

REGULAR MIGRATION

BEITBRIDGE BORDER POST(MATABELELAND SOUTH PROVINCE)

In June 2020, the average daily number of individuals observed at Beitbridge crossing point increased by 14 per cent compared to the previous month. A total of 26,800 movements comprising 13,043 (49%) entries and 13,757 (51%) exits were recorded at the crossing point during the month in review.




Fig 2 – Summary of Regular Migration Movements at Beitbridge Border Post in June 2020

About 89 per cent (23,938) of the migrants were adult male, while 10 per cent (2,763) were adult female and the remaining less than one per cent were minors.

A further analysis of the entries during the month in review shows that the majority of the entries were returning residents (68%), migrants on transit (18%), business visitors (13%), and students comprising less than one per cent, as shown below:

The final destinations for the **2,410** migrants on transit were reported as: Zambia **(58%)**, Malawi **(32%)**, South Africa **(5%)**, Democratic Republic of Congo (DRC) **(3%)**, Mozambique and Tanzania **(1%)** each. However it should be noted that the data on the final destinations of migrants is based on their declaration and must be taken with caution as they only indicate an intention.

Information presented in this report is a compilation of available data from Government sources: Immigration Officers, Border Patrol Officers, Department of Social Welfare and other organizations. DTM team categorized and analyzed the data to produce this Flow Monitoring Report.

Fig 2 below shows cumulative entries and exits at Beitbridge Border Post from April 2020 to June 2020. As shown in the chart there is a visible upward trend in the observed movements which might be attributed to the relaxed COVID-19 movement restrictions by both countries.

CUMULATIVE REGULAR MIGRATION FLOWS THROUGH BEITBRIDGE BORDER POST




Fig 3: Summary Regular Migration Flow from April2020 to June 2020

FORBES BORDER POST (MANICALAND PROVINCE)

A total of **11,400** movements were recorded at the Forbes Border Post during the month of June 2020, representing an **8** per cent decrease in comparison to movements recorded in May 2020.




Fig 4 – Summary of Regular Migration Movements at Forbes Border Post in June 2020

Fig 4 below shows cumulative entries and exits at Forbes Border Post from April 2020 to June 2020. As shown in the chart a declining trend in movements continues as a result of COVID-19 movement restrictions. Entries and exits for the month declined by **6** and **10** per cent respectively from the previous month's movements.




Fig 5- Summary of Regular Migration Movements at Forbes Border Post for Apr - Jun 2020

CHIRUNDU BORDER POST (MASHONALAND WEST PROVINCE)

Between 1 June and 30 June 2020, a total of **21,550** movements were observed at Chirundu Border Post comprising **11,972** entries and **9,578** exits. Out of the total entries recorded during the month in review, less than one per cent **(84)** were Zimbabwean nationals returning home because of the COVID-19 restrictions.

The profiles of the observed movements were Zimbabwean truck drivers (15,522), non-Zimbabwean truck drivers (5,707), Zambian returnees and bus crew members (133), Zimbabwean returnees (84), Zimbabwean students studying in Zambia (42), foreign students (40) and, others with special arrangements (22), as shown in the table below:

MIGRATION HEALTH ASSESSMENTS

IOM carries out health assessments for various categories of migrants, including resettling refugees, labour migrants and displaced persons, either before departure or upon arrival. This reduces contamination risks and manages the potential public health impact of human mobility on migrants, receiving countries and communities.

A total of **144** applicants went through the migration health assessment during the month in review. The applicants comprised **51** per cent females and **49** per cent male as shown below, with **24** per cent being minors below the age of **11** years.




Fig 6 - Cumulative Applicants by Visa Type from May - June 2020

The majority of the applicants who went through the health assessments in June 2020, applied for settlement and dependants visa (42%), followed by work visa (26%), students without scholarship (17%), other visa types (7%), students with scholarship visas (6%) and family reunion visa (2%) as illustrated in Fig 6.




Fig 7 – Cumulative Applicants by Visa Type from May - June 2020

A further analysis of the type of visas applied for during the past two months indicates a desire for long term migration by most applicants, as shown in Fig 7 below.

IRREGULAR MIGRATION

A total of 1,177 Zimbabwean migrants returned from South Africa through the Beit Bridge Reception Centre. Approximately 1,022 (41%) of the returnees in June 2020 were self repatriating, while 108 (9%) came under the IOM assistance programme and 47 (4%) were deportees which included 12 ex convicts.

As at the 30th of June 2020 the total cumulative number of returnees recorded from April 2020, at various points of entry around the country was **10,080** as shown in the table below.
