



From the period 23 – 29 September 2019, a total of 1,441 movements were recorded, they composed of 1,118 arrivals and 323 departures. Arrivals were recorded at locations in Askira/Uba, Bama, Damboa, Dikwa, Gwoza, Jere, Konduga, Mafa, Maiduguri, Mobbar, Monguno and Ngala Local Government Areas (LGAs) of Borno State. Arrivals were also recorded in Demsa, Girei, Gombi, Hong, Madagali, Maiha, Mayo-Belwa, Michika, Mubi South, Mubi South, Numan, Song and Yola South LGAs of Adamawa State. Departures were recorded in Maiduguri Metropolitan Council, Bama, Dikwa, Gwoza, Kaga and Kala/Balge LGAs of Borno State. Departures were also recorded in Fufore, Girei, Hong, Madagali, Maiha, Mayo-Belwa, Mubi North, Numan and Yola South LGAs of Adamawa State.

ETT assessments identified the following movement triggers: voluntary relocation (44%), poor living conditions (28%), improved security (17%), conflict/attack (10%) and military operations (1%).







SUMMARY OF MAJOR MOVEMENTS

Bama: 212 arrivals and 2 departures were recorded in Bama LGA of Borno State. The arrivals include 42 from Buduwa/Bula Chirabe ward and 3 from Lawanti/Malam/Mastari/Abbaram ward and were tracked in Shehuri/Hausari/Mairi ward of Bama LGA. Other arrivals include 21 from Zainnari ward and 10 from Muna ward of Mafa LGA, 101 from Pulka/Bakko ward of Gwoza LGA, 14 from Mairi ward of Jere LGA and 21 from Kolofata in Cameroon. The 2 departures were from Shehuri/Hausari/Mairi ward. 99% of the new arrivals reported to have relocated voluntarily while 1% was reportedly due to poor living conditions. The departures were all voluntary.

Ngala: 139 arrivals were recorded in Ngala LGA of Borno State. The arrivals include 126 from Rann ward of Kala/Balge LGA and 13 from Mashamari ward of Jere LGA. All the arrivals were due to poor living conditions.

Askira/Uba: 93 arrivals and 40 departures were recorded in Askira/Uba LGA of Borno State. The arrivals include 71 from Uba ward. Other arrivals include 5 from Auno/Chabbol of Konduga LGA, 14 from Akko LGA of Gombe State and 3 from Yola North LGA of Adamawa State. The departures include 36 from Askira East ward and 4 from Uba ward. 95% of the new arrivals reported to have relocated due to improved security while 5% relocated voluntarily. 90% of the departures reported to have relocated due to improved security while 10% were reportedly due to poor living conditions.

Monguno: 120 arrivals were recorded in Munguno LGA of Borno State. The arrivals include 45 from Gajiram ward of Nganzai LGA, 71 from Doro/Duguri ward and 4 from Baga ward of Kukawa LGA. 63% of the new arrivals reported to have relocated due to poor living conditions while 38% were reportedly due to the ongoing conflict.

NEW ARRIVAL MALNUTRITION SCREENING SUMMARY (CHILDREN 6-59 MONTHS)

An exhaustive nutrition screening using monitoring of symptoms of acute malnutrition mid upper arm circumference (MUAC) and Oedema was conducted by Nutrition Sector partners for 150 children of 6-59 months. Of the 150 children screened, the MUAC reading recorded 7 children (from accessible areas) in the Red category, 13 in the Yellow category and 130 measured in the Green category. No cases of Oedema were reported in the 5 LGAs reports were received from.

The results also include 13 children from neighbouring Cameroon and Republic of Niger (2 children moved to Bama, 2 to Gwoza and 9 moved to Mobbar); out of the 13 children measured, none were in the red category, 10 were in the green category and 3 children were in the yellow category. All children found with acute malnutrition have been admitted for treatment.
